

Terms For Buying

This is not an absolute auction. Some items sell with reserve or minimum bids. Such items will not be considered sold until reserve bid is confirmed.

All purchases must be settled for in full on auction day. Payment may be made by cash, credit card or cashier's checks. Personal or company checks will be accepted, however, items paid for by check without a bank letter of guarantee will not be released until the check clears our bank.

There is an 10% buyer's premium added to every purchase. A 3% fee for credit card purchases and a 1% fee for debit card purchases.

7% Sales Tax is collected on everything unless a valid sales tax exemption certificate is on file UPON REGISTRATION. Sales Tax is collected on all titled vehicles unless a current auto dealers license is on file UPON REGISTRATION.
